6. In considering the Grievances before it, the SGRC shall follow principles of natural justice.
7. The SGRC shall send its report with recommendations, if any, to the Controller of Examinations and a copy thereof to the aggrieved student, preferably with a period of 15 working days from the date of receipt of the complaint.
8. Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the University level SGRC, within a period of fifteen days from the date of receipt of such decision.
